1. Establishment of the Financial Misconduct Committee (FMC)

A departmental Financial Misconduct Committee (FMC) is established in line with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999), as amended, any other applicable legislation as outlined in the DR&PW Policy on the Reporting and Investigation of Potential Financial Misconduct, and the following DR&PW Policies, Strategies, Plans and Procedures:

- a) The DR&PW Policy on Damages and Losses.
- b) The DR&PW Inventory Management Policy and Standard Operating Procedures (SOPs).
- c) The DR&PW Policy on the Management of Unauthorised Expenditure.
- d) The DR&PW Policy and Procedures on the Management of Irregular Expenditure.
- e) The DR&PW Policy and Procedures on the Management of Fruitless and Wasteful Expenditure.
- f) The DR&PW Risk Management Policy.
- g) The DR&PW Risk Management Strategy.
- h) The Plan: DR&PW Compilation of Policies on Fraud, Corruption and Ethics Management.
- i) The DR&PW Supply Chain Management (SCM) Policy.
- j) The DR&PW Monitoring and Evaluation (M&E) Policy Framework.
- k) The Current DR&PW Internal Audit Plan.

2. Purpose and Accountability of the FMC

- 2.1 Section 51(b)(ii) of the PFMA, 1999, as amended, provides for the AO to take effective and appropriate steps to, amongst others, prevent irregular, fruitless and wasteful expenditure, losses resulting from financial misconduct, and expenditure not complying with operational policies of the DR&PW.
- 2.2 Sections 81 to 86 of the PFMA, 1999, as amended, provide guidelines on how departments should deal with financial misconduct.
- 2.3 Part 4 of the National Treasury Regulations, 2001 and 2005 requires the AO to ensure that an investigation is conducted into any allegation that an official has committed financial misconduct.
- 2.4 It is against the backdrop of the above legislative provisions that a Financial Misconduct Committee (FMC) is established for the DR&PW.

2.5 The FMC is accountable to the HOD/AO and will report to the Internal Audit Committee (IAC) on a quarterly basis.

3. Responsibilities of the FMC

- 3.1 The overall responsibility of the FMC shall be to investigate all financial misconduct and losses to the DR&PW and make recommendations to the HOD/AO on corrective action to be taken, in accordance with the provisions of the DR&PW Policy on the Reporting and Investigation of Potential Financial Misconduct.
- 3.2 The terms of reference of the FMC in fulfilling the above mandate shall be the following:
 - a) Facilitate the development of the DR&PW's procedures on handling cases of possible financial misconduct, losses or damages as a result of negligence.
 - b) Establish criteria for the evaluation of possible financial misconduct, losses or damages.
 - c) Evaluate all cases of possible financial misconduct, which may result in unauthorized, irregular, fruitless or wasteful expenditure.
 - d) Make recommendations to the HOD/AO on appropriate control processes to be implemented to avoid future recurrence.
 - e) Make recommendations to the HOD/AO on appropriate disciplinary action against an official(s) who had committed financial misconduct and/or is responsible for a loss to the DR&PW or has caused damage to the DR&PW's property/asset(s).
 - f) Establish whether appropriate processes were followed to determine liability on the part of the official(s) who was found to have committed financial misconduct and/or are responsible for a loss to the DR&PW or have caused damage to the DR&PW's property/asset(s).
 - g) Make recommendations to the HOD/AO on the writing-off of losses.

4. Membership of the FMC

- 4.1 The following officials shall constitute the Financial Misconduct Committee (FMC):
 - a) an independent, external person as Chairperson, appointed by the HOD:
 - b) the Senior Manager: Financial Management and Accounting;
 - c) the Senior Manager: Supply Chain Management (SCM);
 - d) the Senior Manager: Legal Services;
 - e) the Senior Manager: Strategic Planning Management;

- f) the Manager: Monitoring and Evaluation (M&E);
- g) the Manager: Risk Management;
- h) the Manager: Labour Relations;
- i) the Financial Inspectorate Unit (Secretariat)
- 4.2 All members of the FMC shall be from within the DR&PW.
- 4.3 Members of the FMC shall be formally appointed in writing by the AO (HOD).
- 4.4 The term of office of FMC members shall be twelve (12) months, unless otherwise indicated in writing by the AO (HOD).
- 4.5 Members of the Shared Internal Audit Services and of the Internal Audit Committee (IAC) respectively, will be invited to attend each FMC meeting in an advisory and monitoring capacity.

5. Induction and Orientation of Members of the FMC

Members of the FMC shall be appropriately inducted and orientated regarding their responsibilities and duties.

6. Secretariat of the FMC

The DR&PW Financial Inspectorate Unit shall provide secretariat services to the FMC.

7. Meetings of the FMC

- 7.1 The FMC shall meet regularly as per the meeting schedule to be agreed upon.
- 7.2 The Chairperson, or any member or individual through the Chairperson, may convene additional meetings as and when deemed necessary.
- 7.3 The quorum for FMC meetings to take place and to take authorised collective decisions shall be 50% + 1 member of the FMC.

- 7.4 Attendance of meetings by members is compulsory and any absence of a member for whatever reason must be reported by way of a written apology, forwarded to the Chairperson through the Secretariat, one (1) week in advance, except for instances of medical incapacity.
- 7.5 Notwithstanding the provisions of 6.4 above, if a member is not present for three (3) consecutive meetings, the matter shall be referred to the HOD/AO, through the Chairperson.
- 7.6 The FMC may invite any person to attend an FMC meeting, as deemed appropriate.
