PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2017

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

TERMS OF REFERENCE FOR LANDLORD AND LAND PARCEL OWNERS DATA BASE

Purpose

The Northern Cape Department of Roads and Public Works is the custodian of all immovable assets in the Province. The Department is also responsible for acquiring leased office accommodation on behalf of Provincial Client Departments. To be able to achieve this, DRPW regularly has the need to appoint the property owners/ landlords in the various areas of the Province.

DRPW is calling for *Expression of Interest* from landlords/ property owners with suitable office accommodation space to be included in the Departmental Roster as Landlords for 2019 - 2022. The registered landlords will be considered as and when a need for office accommodation arises from time to time.

Background

1. The Department of Roads and Public Works, as the custodian of Provincial Immovable assets, is responsible for securing and managing alternative office accommodation on behalf of User Departments.
2. The Province has limited properties to utilize as office accommodation to house Provincial Departments and Entities. It is therefore necessary for the Department to source alternative solutions from the open market from time to time to augment the insufficient Provincial stock.
3. The uniqueness of the Province is that having the largest land mass in the Country, the Province has the smallest population and it is sparsely distributed. This makes availability of suitable office accommodation for Provincial Departments a huge challenge.
4. Due to high demand and low supply of suitable office accommodation in the Province, User Departments sometimes find themselves stuck in unsuitable lease agreements and unsuitable buildings and have to renew leases that were not realizing value for money
5. There is limited participation of Black people ,particularly women ,in control that has authority and have power to influence the strategic and operational direction of the business in the property industry.
6. Department, may negotiate to enter into Longer Lease agreement as part of empowerment strategy to designated group i.e Black Women, and Youth, who own 51% of the company/property/ Land Parcel, with the intention of gaining 100% ownership before the end of the lease contract

2. **In application of the above tenure enhancement method, and in following of the qualifying criteria encompassed in this policy, all entities and enterprises with B-BBEE certificate status below level 4 and/or black ownership below 20%, may not be considered for participation in any new leasing and leasehold opportunities except for lease renewals or exceptional circumstances.**

Financial Implications

1. Once the landlord has been placed on the register ,the Dept will match user accommodation needs to the facility and enter into direct negotiations with the landlord/s that may meet the user needs.
2. The approved negotiation will then be reduced into a lease agreement carrying all negotiated terms.
3. The lease agreement will be shared with the user department for monthly rental payments and management by the Dept of Roads and Public Works.

Legal Implications

1. Once approved to be on the Register ,landlords will be notified and their services will be on an as -and -when required basis.
2. Placement on the register does guarantee any landlord work with the Dept.
